PAYMENT**TOTAL ANNUAL FEE DUE AND PAYABLE ON 1ST APRIL 2010.**

All subscriptions must be paid by direct debit (Rule 30g). The Club reserves the right to alter tariffs without prior notice.

Any members whose subscription, together with any payment required from time to time as a condition of membership, is unpaid after 30th April or, in the case of payment by instalments, within one month of the due date for payment of any instalment, ceases to be a member and is therefore disbarred from using any of the Club facilities (Rule 30i and 30j).

If payment is not received at the Club by 1st April, regrettably a late payment charge will become due, equivalent to 2% per month of the renewal invoice, excluding Value Added Tax.

NOTES

5-day members: Golf is limited to weekdays, Monday to Friday, including Bank Holidays.

The Levy is payable with the Subscription and must be used within each Club Year. It can be offset against purchases in the Clubhouse and Tennis & Health Club, with the exception of coaching fees and lessons (golf, tennis, fitness, swimming and junior activities), all green fees (visitor, guest and golf day) and Tennis & Health Club guest fees.

From 1 April 2010, there will be no top up bonus applied to Levy balances. However, a 10% discount will be applied at the point of sale, on levyable items only, if payment is made by Levy. Point of sale discount will not be applied if payment is made by any other method.

Any free Levy given to Members during 2009/10 will expire if unspent by 31 March 2011.

If you pay quarterly the fee is payable on 1st April, 1st July, 1st October 2010 and 1st January 2011. This fee is calculated as one quarter of the Total Annual Fee plus a credit charge equivalent to 8% of the Total Annual Fee. Levy is due in one instalment with the first subscription payment.

Overseas and Country Golf Members are entitled to use the Golf facilities 25 times per year. Overseas and Country Tennis & Health Members are entitled to use the Tennis & Health facilities 25 times per year.

All prices include Value Added Tax at 17.5%.
